KEG-2003H-30A/B is a fast cure liquid silicone rubber for injection molding. It is supplied as two components which are mixed in a 1:1 ratio. Colour paste may be added if required. The thixotropic viscosity of KEG-2003H-30A/B is low enough to allow easy pumping by common injection molding systems. Depending on the specific requirements, KEG-2003H-30A/B can help to reduce costs of postcuring significantly due to low volatile content.

The components A and B are ready to use products. The mixture of component A and component B in the ratio 1:1 is injected into the heated mold (temperatures around 180 °C).

The injected silicone mixture vulcanizes within seconds to the final required shape depending on the thickness. KEG-2003H-30A/B is suitable for the production of high quantities, especially when good demolding properties and a short curing time are required.

The excellent processing consistency allows a stable high productivity utilizing short cycle times.

Postcuring: It depends on the application if postcuring is required. Postcuring might lower the dynamic stress resistancy. Tests in realistic circumstances need to be done in advance to determine the necessity of postcure.
